# CERTIFIED RECORD OF LAND CORNER MONUMENTATION (Reference FSH 5681.65)

History of original corner establishment:

Interior 1/16 section corner, not previously established or monumented.

Description of corner evidence found:

Corner location determined by single proportionment between the N 1/4  
established by BLM Cadastral Survey of 1960, and the C 1/4 established  
during the course of this survey.

Description of monument and accessories I established to perpetuate the  
original location of this corner

Monument consists of a 2 1/2 inch brass disk welded to the top of a 2 inch  
galvanized iron pipe, approximately 30 inches in length, with a flat plate  
of iron approximately 8 inches in diameter welded to the base of the pipe,  
and is buried approximately 20 inches in the ground with a mound of rock  
around the base of the monument.
