CERTIFIED RECORD OF LAND CORNER MONUMENTATION

(Reference FSH 581.65)

History of original corner establishment:

Original corner set in 1874 by G. L. O. by private contractor. Field notes call for an unmarked rock 16 X 12 X 8. No accessories noted. Closest tie is 30 chains south which is a summit of a ridge. No other ties in any direction except the closest corners which were quarter section corners. No knowledge of this corner could be obtained from any local resident contacted.

Description of corner evidence found:

None found. Location re-established by double proportionment between the closest found corners north and south, and east and west.

Description of monument and accessories I established to perpetuate the original location of this corner

Monument consists of a 2 1/2 inch brass disk welded to the top of a 2 inch galvanized iron pipe, approximately 30 inches in length, buried approximately 20 inches in the ground with a mound of rock set around the base. Flat piece of steel is welded to the base of the monument. Disk is stamped with metal dies as follows:

A 19" P.P. bears N 29° E 2.67 chains  
A 18" P.P. bears S 25° 20' E 2.55 chains  
A 22" Juniper bears S 59° W 77 links  
A 12" P.P. bears N 81° W 1.26 chains
