## Survey No. B. 19

Resurvey for portions of secs. 3, 4 and 5, T 9 S. R && E, W.M. Blakeley & MacKenzie, Roy Boggs, L. Sweek and John Murphy claimants. Made upon application of Roy Boggs.

October &, 1917.

Commencing at corner on township line, and between secs. 33 and 34, T & S, R 28 E, W.M. Meridian obtained by back sight section corner one mile to north, and common to secs. 27, 28, 33 and 34. Both of these corners being well marked and witnessed, and recognized by all residents of this locality.

Thence due west on township line
1.58 chs. Established corner for secs. 4 and 5, T 9 S, R 28 E.
A basalt rock 10 x 8 x 4, properly scribed, and set in mound of stone.

Thence south on section line between 4 and 5
Established a 1/16 corner common to lots 4 and 5, sec 4,
and lots 1 and 8, sec 5, a basalt rock 11 x 6 x 5, properly
marked and set in mound of rock.

Thence due west between first and second tiers of lots in section 4.

- 20.00 " Established a 1/16 corner, a basalt rock 10 x 5 x 4 properly marked.
- 40.00 " Established a 1/16 corner, a basalt rock 12 x 8 x 5 properly marked.
- 60.00 ". Established a 1/16 corner, a basalt rock 8 x 8 x 6 properly marked.
- 80.00 " North and south sec. line between secs. 5 and 6. Properly marked and crossed a ledge of white chalk rock, 6' high x 8 feet wide.
- Thence returned to 1/16 corner common to lots 4 and 5, sec 4 and lots 1 and 8 sec. 5. Thence due south on section line. Established a 1/16 corner, A basalt rock 11 x 7 x 6 properly marked and set in mound of rock.
- 40.00 " Original 1/4 corner plainly marked 1/4 S. hears S 85° W, 0.08 chains.
- October 9, 1917.

  Established a 1/16 corner, a basalt rock 9 x 7 x 5 properly marked and set in mound of rock. Continued this course south for checking on corner common to secs 4, 5, 8 and 9, but could not find the original corner. Established one, a basalt rock 12 x 8 x 4 properly marked and set in mound of rock.

Thence returned to 1/16 corner common to NW/4 SW/4, SW/4 SW/4 sec. 4 and NE/4 SE/4, SE/4 SE/4 sec 5

Thence North 89° East on 40 line. Claimants are Roy Boggs and L. Sweek. Set stakes on line on tops of ridges for guides for setting fence.

North and south section line between secs. 3 and 4. Established a 1/16 corner common to NW/4 SW/4, SW/4 SW/4 sec. 3, and NE/4 SE/4, SE/4 SE/4 sec. 4, a basalt rock 12 x 5 x 4, properly scribed.

Thence south on section line. John Eurphy and L.
