

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

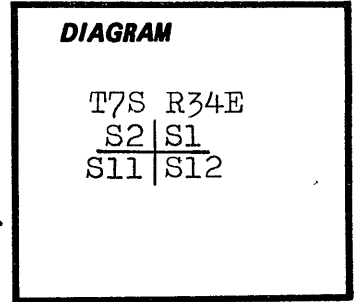

History of original corner establishment:

Corner was set by Herman D. Gradon in 1884 under Contract No. 499, dated March 11, 1884.

Set a post, 4" X 4" X 4' long 20" in the ground, marked T7SS1 on N.E., R34ES12 on S.E., S11 on S.W. and S2 on N.W. faces, with 1 notch on East and 5 notches on South edges, from which bears;

- A Pine, 7" diam. N. 60°E., 46 lks., marked T7SR34ES1BT.
- A Pine, 7" diam., S.44°E., 32 lks., marked T7SR34ES12BT.
- A Pine, 8" diam., S.36°W., 28 lks., marked T7SR34ES11BT.
- A Pine, 8" diam., N.81°W., 18 lks., marked T7SR34ES2BT.



Description of corner evidence found:

Post gone

- (7" diam.) N. 60°E., 30.4'. down and rotted, B.T. scribes visible on piece of trunk. (Pine)
- 12" D.B.H., (8") Lodgepole Pine, down w/ scribes T7SR34ES11BT, S.36°W., 18.48'.
- (7" diam. Pine), down and rotted, no visible scribes, S.44°E., 21.12'.
- (8" diam. Pine), down and on face, on piece of wood chopped out are scribes, N.81°W., 11.88'.

Description of monument and accessories established to perpetuate the original location of this corner:

Set; a 2½" diam. Alum. cap on a 2½" X 30" alum. pipe at record distances from B.T.'s. Cap marked per sketch. Set steel posts 4'± E.&W. with attn. signs and mon. signs with attached.

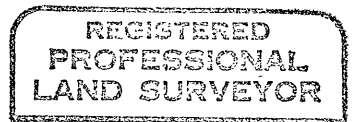
- 6" D.B.H. White Fir N. 57°E., 36.8', scribed T7SR34ES1BT.
- 9" D.B.H. Spruce, S.86½°E., 39.3', scribed T7SR34ES12BT.
- 5" D.B.H. White Fir, N 17½°W., 8.2', scribed "X" BT.
- 10" D.B.H. Spruce, S.15½°W., 26.4', scribed T7SR34ES11BT.

Set a brass washer mkd. RPLS 1910 btwn. B&T on each B.T. , set B.T. tags, attn. signs, painted bands and faces red.

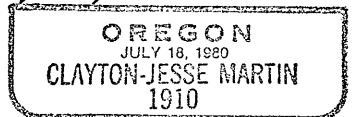
Distances to B.T.'s. are to center of tree 1 foot above the root crown.

Bearings are magnetic with 20° East declination.
