

CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Index: Z-15

Quarter corner Sec. 34, T.7S. and Sec. 3, T.8S. of R.31E., W.M.
 Original corner was set by Frank Campbell under Contract Number 380 in 1881.
 His record reads: Set Pine post from which:
 24" Y. Pine bears South 58 lks.
 15" Y. Pine bears N26°W 39 lks.

In 1980 PLS 896 remonumented this corner. His record reads: Found no evidence of the original corner or its accessories exist.

Set 2 1/2" Brass Cap on 2 1/2"x30" Gal. steel pipe marked as shown 24" in the ground. No stone available.

From which:

8" Pine bears N2°E, 38.1 ft. scribed 1/4 S34 upper blaze and a lower blaze scribed BT and with a brass disk stamped PLS 896. 14" Wh. Fir bears S36°W, 36.8 ft. scribed 1/4 S34 upper blaze and a lower blaze scribed BT and with a brass disk stamped PLS 896.

Description of corner evidence found:

Found the galvanized pipe with brass cap stamped as shown in the diagram. From which:

A 13" dbh Ponderosa Pine bears N2°E, 38.1' with visible scribe.
 A 23" dbh White Fir bears S36°W, 36.8' with healed blaze.

Description of monument and accessories I established to perpetuate the original location of this corner:

The bearings were based on the record bearings of the existing witness trees.

I set the following new witness trees:

A 14" dbh Ponderosa Pine bears S57 1/2°E, 50.7' scribed 1/4 S3 BT.
 A 14" dbh Ponderosa Pine bears N33 1/2°W, 116.8' scribed 1/4 S34 BT.

An aluminum washer stamped RLS852 is nailed between the letters B and T on each new tree. All the BT's have LSM and BT signs attached. Painted 6" red bands around all the trees and painted the scribe blazes red.

This work was completed December 28, 1993.
