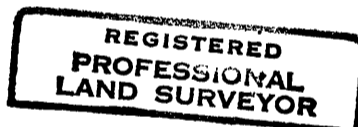
Description of corner evidence found:

Found the corner monument as described from which:
 A 13" dbh Ponderosa Pine bears N.47°E., 42.2' with visible scribe.
 A 12" dbh Douglas Fir bears N.43 1/2°W., 30.0' with visible scribe.
 A 15" dbh Douglas Fir bears S.63 1/2°W., 52.1' with healed blaze.
 A dead and down Ponderosa Pine bears S.42 1/2°E., 63.4' with visible scribe.

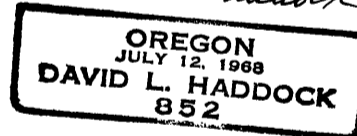
Description of monument and accessories I established to perpetuate the original location of this corner:

Set new bearing trees as follows:
 A 15" dbh Ponderosa Pine bears S.86 3/4°E., 81.1' scribed T7SR32ES15BT.
 The bearings were based on the record bearings to the existing BT's.
 An aluminum washer stamped RLS 852 is nailed between the letters B and T on the new tree. All the BT's have LSM and BT signs attached.
 Painted 6" red bands around all the trees and painted the scribe blazes red.
