

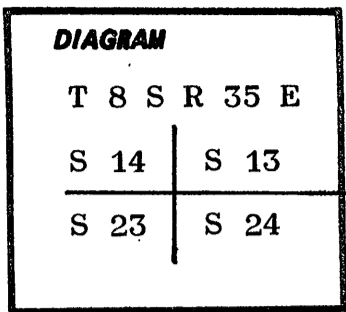
CERTIFIED RECORD OF LAND CORNER MONUMENTATION

History of original corner establishment:

Corner established by Herman D. Gradon under GLO contract No. 499, dated March 11, 1884.

Surveyor's General records state:

Set a post 4 ft. long 4 ins. square 24 ins. in the ground for cor. to secs. 13, 14, 23, and 24 marked T 8 S S 13 on NE, R 35 E S 24 on SE, S 23 on SW, and S 14 on NW faces with three notches on S and 1 notch on E edges; from which



- A pine 7 ins diam bears N 54° E, 59 lks dist marked T 8 S R 35 E S 13 BT
- A pine 7 ins diam bears S 52° E, 42 lks dist marked T 8 S R 35 E S 24 BT
- A pine 7 ins diam bears S 08° W, 7 lks dist marked T 8 S R 35 E S 23 BT
- A pine 7 ins diam bears N 55° W, 34 lks dist marked T 8 S R 35 E S 14 BT

Description of corner evidence found:

A beetle killed pine 10 ins diam with full scribes for section 24 BT. At record location as determined by the bearing tree found the rotten remains of a wood post to a depth of 15 ins.

Description of monument and accessories I established to perpetuate the original location of this corner:

Set a 2½ in. brass cap on a 2 in. iron pipe 31 ins. long 28 ins. in the ground with a surrounding rock mound.

- A pine 8 ins. diam. bears N 65° E, 35.0 ft dist mkd T 8 S R 35 E S 13 BT
- A fir 5 ins. diam. bears S 53° E, 18.8 ft dist mkd T 8 S R 35 E S 24 BT
- A fir 5 ins. diam. bears S 22° W, 21.9 ft dist mkd T 8 S R 35 E S 23 BT
- A pine 8 ins. diam. bears N 22° W, 13.1 ft dist mkd T 8 S R 35 E S 14 BT
