NARRATIVE:

NARRATIVE:
This survey was performed at the request of Daniel Harris. The purpose of this survey was to locate the northeast corner of Mr. Harris' lot. Said northeast corner being where the east line of Lot 3, Amended Reservoir Addition to the Town of Prairie City, intersects the south right of way line of U.S. Highway 26.

A search was made of the available records pertaining to this survey. Field measurements were made to locate existing monuments, corner evidence, and lines of occupancy in this area. A new monument was set at the position determined, according to the best available evidence found, as shown hereon.

Reservoir Addition was surveyed and platted by D.W.C. Nelson in March, 1911. In December, 1911, Burton Adams reconfigured Reservoir Addition when he surveyed and platted the Amended Reservoir Addition. During this current survey we found original monuments from both of these additions, as shown hereon. The State Highway Department found the monuments of the Reservoir Addition, as shown on their strip map No. 5B—23—5. From this map; the right of way deed in Book 43, Page 614; the found original Addition monuments; and the highway department monument found at Station 748+11.0 (40 ft. right), we positioned the northeast corner of Mr. Harris' lot

In Book 43, Page 614, deeds, Patsy Daly, granted highway right of way to a line 40 feet south of the centerline of the highway through said Lot 3. I held the 40 foot dimension from the centerline of the highway, as shown hereon, and intersected that line with the east line of Lot 3, Amended Reservoir Addition.
