

NARRATIVE:

PURPOSE:
THE PURPOSE OF THIS SURVEY WAS TO MONUMENT ANGLE POINT 759 OF THE NORTH FORK JOHN DAY UNIT OF THE NORTH FORK JOHN DAY WILDERNESS.

HISTORY:

1883, FRANK W. CAMPBELL, U.S. DEPUTY SURVEYOR, SURVEYED THE NORTH LINE OF THE SECTION WHILE SURVEYING THE TOWNSHIP LINE UNDER CONTRACT NO. 468.

1884. HERMAN D. GRADON. U.S. DEPUTY SURVEYOR. SUBDIVIDED THE TOWNSHIP UNDER CONTRACT NO. 499.

1985—1986, CLAYTON J. MARTIN, REGISTERED LAND SURVEYOR NO. 1910, SUBDIVIDED THE SECTION AND MARKED THE BOUNDARY BETWEEN PRIVATE AND NATIONAL FOREST SYSTEMS LANDS WITH FOREST SERVICE METAL PROPERTY BOUNDARY SIGNS WIRED TO METAL FENCE POSTS (GRANT COUNTY MAP SURVEY NO. 909).

PROCEDURES:
THE DESCRIPTION UTILIZED TO LOCATE ANGLE POINT 759 WAS OBTAINED FROM THE PERMANENT OPEN 2320 FILES LOCATED IN THE SUPERVISIOR'S OFFICE OF THE UMATILLA NATIONAL FOREST LOCATED AT PENDLETON, OREGON.

ANGLE POINT 759 WAS ESTABLISHED AT A POINT 500 FEET SOUTHERLY OF AND PERPENDICULAR TO THE CENTERLINE OF FOREST ROAD 5225 ON THE NORTH—SOUTH CENTERLINE OF THE SW 1/4 OF SECTION 2.

THE SURVEY WAS CONDUCTED USING A TOPCON GTS-4 TOTAL STATION. ALL BEARING TREES WERE TIED USING A WARREN-KNIGHT SURVEYOR'S COMPASS, WITH DISTANCE MEASUREMENTS TAKEN AT THE SIDE CENTER OF THE BEARING TREES ONE FOOT ABOVE THE ROOT CROWN. DIAMETERS WERE MEASURED AT BREAST HEIGHT.

ALL NEW BEARING TREES ARE DOUBLE BLAZED AND HAVE A 3/4 INCH DIAMETER BRASS WASHER STAMPED "RLS 2308" NAILED NEXT TO THE "BT" SCRIBING ON THE LOWER BLAZE.

THE WILDERNESS BOUNDARY WAS MARKED BY ATTACHING METAL WILDERNESS BOUNDARY SIGNS TO THE EXISTING FENCE POSTS ON THE NORTH—SOUTH CENTERLINE OF THE SW 1/4 BETWEEN AP—759 AND THE SW 1/16 OF SECTION 2. THE WILDERNESS BOUNDARY LEADING INTO AP—759 WAS BLAZED AND MARKED BY ATTACHING SIGNS TO TREES WITHIN A 4 FOOT WIDE CORRIDOR OF THE WILDERNESS BOUNDARY.

FILED BOOK ONE IS ON FILE AT THE SUPERVISIOR'S OFFICE OF THE UMATILLA NATIONAL FOREST.

BOTH BTS HAVE A 3/4" BRASS WASHER MARKED "RPLS 1910" NAILED TO THE LOWER BLAZE BY THE "BT" SCRIBING.
