

THIS SURVEY WAS PERFORMED AT THE REQUEST OF VICKI LUNDBOM. THE PURPOSE OF THIS SURVEY WAS TO CREATE PARCELS 1 AND 2 OF THIS LAND PARTITION AND TO SET MONUMENTS ON THE DIVISION LINE BETWEEN SAID PARCELS.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING CONTROLLING MONUMENTS. WE RETRACED THE APPURTENANT PORTIONS OF RECORD SURVEY NO.'S 324, 362, 497 AND 762, WHICH I SURVEYED IN 1973, APR. 1975, JAN. 1978, AND NOV. 1982 TO NOV. 1983, RESPECTIVELY. THE TWO NEW MONUMENTS WERE SET IN ACCORDANCE WITH THE EVIDENCE FOUND AND AT POSITIONS APPROVED BY MS. LUNDBOM, AS SHOWN HEREON. WE DID NOT FULLY RESURVEY PARCEL 2 FOR THIS PARTITION.

I SET THE NORTH MONUMENT ON LINE BETWEEN THE FOUND PINS AT THE NW AND NE CORNERS OF THE TRACT. I SET THE SOUTH MONUMENT AT THE INTERSECTION WITH THE NORTHERLY RIGHT OF WAY LINE OF COUNTY ROAD NO. 74, AS SHOWN.

THE SOUTHERLY BOUNDARY IS ALONG THE CENTERLINE OF ROAD EASEMENT "A", THE CENTERLINE OF WHICH DOES NOT COINCIDE WITH THE CENTERLINE OF COUNTY ROAD NO. 74. BOTH PARCELS ARE SUBJECT TO ROAD EASEMENT "A" AND THE DEDICATED RIGHT OF WAY FOR COUNTY ROAD NO. 74.

(1) THE NET AREA OF EACH PARCEL IS CALCULATED TO THE NORTHERLY RIGHT OF WAY LINE OF COUNTY ROAD NO. 74. THE GROSS AREA INCLUDES THAT AREA WITHIN THE RIGHT OF WAY OF COUNTY ROAD NO. 74 LYING NORTHERLY OF THE CENTERLINE OF ROAD EASEMENT "A".

(2) REGARDING THE LINE AND CURVE TABLE: THE CENTERLINE OF ROAD EASEMENT "A" IS DENOTED BY THE LETTER "A" PRECEDING THE LINE OR CURVE NUMBER. THE CENTERLINE OF COUNTY ROAD NO. 74 IS DENOTED BY THE LETTER "R" PRECEDING THE LINE OR CURVE

(3) I FIND NO RECORD OR EXISTENCE OF AN APPURTENANT GEODETIC CONTROL MONUMENT WITHIN 1/2 MILE OF THIS LAND PARTITION.

DECLARATION

KNOW ALL PEOPLE BY THESE PRESENTS THAT I, VICKI J. LUNDBOM, HAVE CAUSED THE LANDS DESCRIBED IN THE SURVEYOR'S CERTIFICATE TO BE PARTITIONED INTO PARCELS IN ACCORDANCE WITH THE PROVISIONS OF ORS CHAPTER 92, AS SHOWN ON THE ANNEXED MAP.

SAID PARCELS SUBJECT TO THE FOLLOWING:

(1) RIGHTS OF THE PUBLIC IN STREETS, ROADS, AND HIGHWAYS.

(2) RESERVATION, INCLUDING THE TERMS AND PROVISIONS THEREOF, AS SHOWN IN WARRANTY DEED FROM RLC INVESTMENTS, INC., A CORPORATION, TO TERRY B. LYONS, DATED AUG. 13, 1974 IN DEED BOOK 112, PAGE 66, TO WIT: RESERVING TO THE GRANTOR, ITS SUCCESSORS AND ASSIGNS, AN EASEMENT IN COMMON OVER AND ALONG THAT PORTION OF ROAD EASEMENT "A" TRAVERSING THE PROPERTY DESCRIBED ABOVE, FOR THE PURPOSE OF INGRESS AND EGRESS TO COUNTY ROAD

(3) DECLARATION OF DEDICATION, INCLUDING THE TERMS AND PROVISIONS THEREOF, TO THE PUBLIC, DATED MARCH 18, 1980, RECORDED FEB. 10, 1982, IN BOOK 125, PAGE 939, DEED RECORDS OF GRANT COUNTY, OREGON, AFFECTING ROAD EASEMENT "A" AS DESCRIBED IN DEED BOOK 110, PAGE 900.

(4) THE COMMON EASEMENTS REFERRED TO HEREIN ARE SUBJECT TO RIGHTS OF WÁY, ACCESS RESTRICTIONS, AGREEMENT REGARDING MAINTENANCE AND CONTROL OF THE OLD HIGHWAY, AND RIGHTS OF THE UNITED STATES OF AMERICA.



LUNDBOM, IN DEED DATED JULY 27, 1995, RECORDED AUGUST 4, 1995, AS INSTRUMENT NO. 951399, DEED RECORDS OF GRANT COUNTY, OREGON, TO WIT: "GRANTOR QUITCLAIMS TO GRANTEE AN INTEREST IN COMMON WITH GRANTOR TO AN EASEMENT IN COMMON WITH OTHERS ENTITLED TO THE USE THEREOF, OVER AND ALONG ROAD EASEMENT "A" FOR THE PURPOSE OF INGRESS AND EGRESS TO COUNTY ROAD NO. 47, AS SOLVETTING DESCRIBED IN BOOK 110, PAGE 900, DEED RECORDS OF GRANT COUNTY, OREGON."
