

<u>IARRATIVE</u>

THIS SURVEY WAS PERFORMED AT THE REQUEST OF THERESA SANDERSON. THE PURPOSE OF THIS SURVEY WAS TO LOCATE THE PROPOSED PROPERTY ADJUSTMENT LINES, AS SHOWN HEREON. ALSO, TO LOCATE THE SHOP BUILDING AND THE PROPOSED ACCESS AND BUILDING MAINTENANCE EASEMENT, SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE THE APPURTENANT MONUMENTS OF RECORD SURVEY NO'S. 1198 AND 1228, WHICH I COMPLETED IN JAN., 1992 AND JUN. & OCT., 1992 RESPECTIVELY. WE FOUND THE NECESSARY CONTROLLING MONUMENTS, AS SHOWN HEREON.

THE NEW MONUMENTS WERE SET ON THE PROPOSED PROPERTY ADJUSTMENT LINES AT LOCATIONS APPROVED BY MS. SANDERSON AND CLIFFORD HAMMOND, THE ADJOINING NEIGHBOR.
