

NARRATIVE:

The purpose of this survey was to maintain the posted boundary between the Private and National Forest System Lands.

HISTORY:

1881, F. W. Campbell, U.S. Deputy Surveyor, subdivided the Township under General Land Office contract number 380.

1972, Douglas M. Ferguson, Registered Land Surveyor No. 848, remonumented the corner of sections 23, 24, 25 and 26 (Filed Form R6—7100—57 at Grant County Surveyor's Office 10/16/72).

1979, William R. Wells, Registered Land Surveyor No. 1106, subdivided section 23 (Grant County Map of Survey No. 599).

PROCEDURES:

The survey was conducted using a Topcon GTS-4 total station. The basis of bearing for this survey is Grant County Map of Survey No. 599.

The property boundary was maintained by replacing the existing orange fiberglass posts with 6 foot steel fence posts with attached metal property boundary signs. The fence posts are within one foot of the surveyed boundary.

Bearing trees were tied using a Warren-Knight Surveyors Compass, with magnetic declination 19° East, and distance measurements were taken at side center one foot above the root crown. All new bearing trees are double blazed and have a 3/4 inch diameter brass washer stamped "RLS 2308" nailed to the lower blaze by the "BT" scribing.

The field notes for this survey are on file at the Supervisor's Office of the Umatilla National Forest located at Pendleton, Oregon.

540300 1/4 Corner of Sections 23 and 26

Found a 2 1/2" iron pipe, with a 3" brass cap, projecting 16" out of the ground, surrounded by a rock mound 3 foot in diameter by 1 foot high, marked as shown, from which:

13" Juniper, S 23° E, 151.7 feet, with scribing "1/4 S26 BT" visible on partially healed blaze.
15" Juniper, N 44° W, 81.2 feet, with scribing "1/4 S23 BT" visible on partially healed blaze with a 3/4" brass washer stamped "PLS 1106" nailed near the "BT" scribing.

New BT's: 9" Juniper, N 44 1/2° E, 102.3 feet, scribed "1/4 S23" "BT". 18" Juniper, S 64 1/2° W, 202.6 feet, scribed "1/4 S26" "BT".

Corner of Sections 23, 24, 25 and 26

Found a 2 1/2" iron pipe, with a 3" brass cap, projecting 4" out of the ground, marked as shown, from which:

23" Ponderosa Pine, N 77 1/2° E, 21.1 feet, with healed double blaze.
13" stump, S 39 ° E, 29.4 feet, with scribing "8SR31ES25" "BT" visible on a partially healed double blaze on wind thrown Ponderosa Pine Snag lying next to the stump.
40" wind thrown Ponderosa Pine Snag, S 71° W, 58.7 feet, with axe marks visible on chopped open blaze.

15" wind thrown Ponderosa Pine Snag, S 73 1/2° W, 41.0 feet, with snag lying on blaze. 23" Ponderosa Pine, N 63° W, 68.7 feet, with healed double blaze.

15" Juniper, S 58° W, 41.4 feet, scribed "T8S R31E S26" "BT".
