NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF FR. ROBERT VAN SICKLER ACTING IN BEHALF OF ST. ELIZABETH CATHOLIC CHURCH. THE PURPOSE OF THIS SURVEY WAS TO LOCATE EXISTING CORNER MONUMENTS AND TO ESTABLISH THE REMAINING CORNERS OF THE ST. ELIZABETH CATHOLIC CHURCH AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. WE MADE FIELD MEASUREMENTS TO LOCATE EXISTING CONTROLLING MONUMENTS OF RECORD AS PREVIOUSLY FOUND OR ESTABLISHED IN SURVEY NO.'S 803, 971 AND 1129 WHICH I SURVEYED IN FEB. 1984, MAY 1987 AND DEC. 1989, RESPECTIVELY.

NEW MONUMENTS WERE SET IN ACCORDANCE WITH THE EVIDENCE FOUND, THE BRENT ADDITION PLAT AND THE DEED RECORD AS SHOWN HEREON.
