

NARRATIVE

This map was prepared at the request of King Williams, on behalf of Clearwater Land Exchange—Oregon. The purpose of this map is to indicate the acceptable corners for the subdivision of Sections 25, 26, 35 and 36. This map is prepared from record surveys within these four sections, no survey was performed.

The BLM performed a dependant resurvey of these four sections, see Survey No. 286, dated and approved, August 31, 1972. During this survey the BLM established corners on the exterior of Sections 25, 35 and 36 and subdivided Section 26. The subdivision of Section 26 by the BLM has not been accepted nor have many of the corners, see the table of unacceptable BLM monuments. Positions which rely upon the BLM monuments at the N1/4 corner and the S1/4 corner of Section 35 are not accepted. Survey No. 286 was disputed by Grant County, the City of John Day and the City of Canyon City.

The County Surveyor monumented the N1/4 corner and the S1/4 corner of Section 35, see Survey No. 361, dated March 1975. The position of the NE corner of Section 35 has been established by double proportion, see Survey No. 1457, dated September 1997. Many surveys have been done in these four sections in the past 26 years and none have relied upon the disputed BLM corners of Survey No. 286.

This map is intended to shown the acceptable corners for the subdivision of Section 25, 26, 35 and 36. Clearwater Land Exchange—Oregon is currently in the process of acquiring patent deeds to selected the federal lands within the four sections. Soon after Clearwater Land Exchange—Oregon has title to these lands the tracts will be sold. This map is referenced upon the deeds in order to clarify the intent to use acceptable corners, not the disputed BLM monuments, to describe the property being conveyed by the Clearwater Land Exchange—Oregon.
