Survey Completed July 9, 2004

NARRATIVE

THIS SURVEY WAS PERFORMED TO CORRECT CERTAIN CORNER LOCATIONS AS MONUMENTED ON GRANT COUNTY MAP OF SURVEY NO. 645 AS SHOWN HEREIN. ALSO WHILE PERFORMING THIS SURVEY, CERTAIN LINES IN SECTIONS 22 & 23 ARE LOCATED AND MARKED FOR STILL REVEAL. THIS SURVEY WAS PERFORMED AND FILED IN CONJUNCTION WITH MAP OF SURVEY NO. 1706 BY WILLIAM WELLS.

THE INTERIOR LINES OF T.8S., R.31E., W.M. WERE ORIGINALLY SURVEYED BY F.W. CAMPBELL UNDER G.L.D. CONTRACT NO. 380, DATED MARCH 19, 1881.

IN 1972, I PERFORMED A CONTRACT WITH THE U.S.D.A. FOREST SERVICE TO SEARCH, EVALUATE AND MONUMENT CORNERS IN THIS AREA. I RECOVER WHAT I BELIEVED TO BE THE ORIGINAL STONE AT THE SOUTH 1/4 CORNER OF SECTION 14 AND SET A MONUMENT. NO MEASUREMENTS ARE MADE TO OTHER CORNERS OR EVIDENCE UNDER THIS CONTRACT.


IN 1979, WILLIAM WELLS PERFORMED A SURVEY UNDER CONTRACT WITH THE U.S.D.A. FOREST SERVICE, FILED AS GRANT COUNTY MAP OF SURVEY NO. 599. MR. WELLS PROPORTIONED THE SECTION CORNER TO THE SOUTH 1/4 OF SECTION 14, THE CORNER 4 MILES TO THE WEST, 18, 19 & 24, THE CORNER 1 MILE TO THE NORTH, 14 & 15, AND THE CORNER 2 1/2 MILES TO THE SOUTH, 34 & 35.

IN 1980, I PERFORMED A SURVEY, AGAIN UNDER CONTRACT WITH THE FOREST SERVICE, GRANT COUNTY MAP OF SURVEY NO. 645, FILED ON JANUARY 12, 1981. I UTILIZED BOTH OF THE MONUMENTS STATED ABOVE TO SUBDIVIDE AND MARK BOUNDARIES IN SECTION 14.


IN 1999, DENNIS GAYLORD REPORTED FINDING THE ORIGINAL STONE AT THE SECTION CORNER TO SECTIONS 15, 16, 21 & 22 AND MONUMENTED IT'S POSITION.

IT WAS BROUGHT TO MY ATTENTION, IN 2002, THAT MR. GAYLORD MAY HAVE RECOVERED THE ABOVE SAID SECTION CORNER. MR. WELLS PROVIDED A MAP SHOWING THE RELATIONSHIP OF THE GAYLORD MONUMENT TO THE SURROUNDING MONUMENTS PREVIOUSLY SET BY PROPORTIONATE MEASURE. MR. WELLS AND I CONDUCTED SEVERAL FIELD REVIEWS OF CORNERS, INCLUDING THE SAID GAYLORD CORNER AND THE SW CORNER OF SECTION 14. APPROXIMATELY 120' EAST OF THE PROPORTIONED SW CORNER OF SECTION 14, MR. WELLS FOUND A MARKED STONE, LYING LOOSE, NEAR AN OLD FENCE CORNER. AS STATED IN HIS NARRATIVE, THIS STONE WAS NOT THERE IN 1979. THE POSITION OF THIS STONE FITS RECORD FROM THE SECTION CORNERS TO THE NORTH AND EAST. THIS PROMPTED ME TO REVIEW THE EVIDENCE THAT I RECOVER IN 1972 AT THE SW CORNER OF SECTION 14. I FOUND NO VISIBLE MARKS ON THE STONE. I DO NOT ACCEPT THE 1972 POSITION OF THE SW CORNER OF SECTION 14 AND RE-MONUMENT IT AT PROPORTIONATE MEASURE. THE MONUMENTS SET BY PROPORTIONATE MEASURE DURING MY 1980 SURVEY IN SECTION 14 ARE AMENDED AS SHOWN HEREIN TO THEIR CORRECT POSITIONS.
