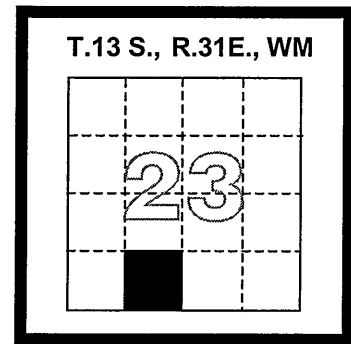
HISTORY OF ORIGINAL CORNER ESTABLISHMENT:

NORTHWEST CORNER OF BLOCK A, FIRST MUNICIPAL
ADD. TO JOHN DAY.

Survey No. 1008 states Found 5/8" Iron Pin with reference to Grant County
Survey 124.

DESCRIPTION OF CORNER EVIDENCE FOUND:

On January 13, 2004, found a 5/8" diameter iron rod (Concrete reinforcing rod), flush in the ground,
unmarked.

As part of a mapping survey in progress on this day for the purpose of street improvement design, survey
measurements were made to the existing location of this found survey monument.

**DESCRIPTION OF MONUMENT AND ACCESSORIES I ESTABLISHED TO PERPETUATE THE
ORIGINAL LOCATION OF THIS CORNER:**

The monument found on Jan. 13, 2004 was removed by street
construction activities during the summer of 2004.

On October 26, 2004, set a 5/8" diameter by 30" long Iron Rod
(Concrete reinforcing rod), flush in the ground, with yellow plastic cap
attached, marked "APA". This monument was placed at the location of
the monument found and tied on Jan. 13, 2004 as described above.

The purpose of this Certified Record of Land Corner Monumentation is
to continue the chain of history of the location and nature of the
monument described herein, and to comply with Oregon Revised
Statutes, Chapter 209.150.
