THIS SURVEY WAS PERFORMED AT THE REQUEST OF TERRY SOWA.
THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT
THE PROPOSED PROPERTY ADJUSTMENT LINE, AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. I MADE FIELD MEASUREMENTS TO LOCATE THE FENCES AND APPURTENANT MONUMENTS SHOWN HEREON.

MR. SOWA'S TRACT WAS SURVEYED BY ROBERT BAGETT IN AUGUST, 1970 AND RECORDED AS MAP OF SURVEY NO. 198. I FOUND THE 5/8" IRON PINS FROM SAID SURVEY, ALONG THE EASTERLY LINE OF THIS TRACT, AS SHOWN. THE MONUMENT AT THE SW CORNER OF MR. SOWA'S TRACT, ALSO SHOWN ON RECORD SURVEY NO. 198, IS NOT IN RECORD POSITION.

I DETERMINED THE WEST LINE OF MR. SOWA'S TRACT BY HOLDING THE NORTHERN MOST FOUND MONUMENTS SHOWN HEREON AND RUNNING A RECORD BEARING OF S09'00'00"E.

I SET NEW MONUMENTS ON THE PROPOSED PROPERTY ADJUSTMENT LINE ACCORDING TO THE EVIDENCE FOUND AND AT LOCATIONS APPROVED BY MR. SOWA, AS SHOWN HEREON.
