
# DETAIL

### NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF TAMMY BREMNER, CITY MANAGER FOR CANYON CITY. THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT THE REMAINING CORNERS OF CITY—OWNED PROPERTY IN THE SW1/4 OF SECTION 36, AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. WE MADE FIELD MEASUREMENTS TO LOCATE APPURTENANT MONUMENTS, ROADS AND FENCES, SHOWN HEREON.

WE RETRACED THE SW1/4 OF SECTION 36 AND RECOVERED APPURTENANT MONUMENTS FROM RECORD SURVEY NO.'S 272, 286, 1088, 1139 AND LAND PARTITION NO. 96-19, AS SHOWN. I ACCEPTED THE MONUMENTS AS SHOWN HEREON. THE SW1/4 WAS SUBDIVIDED IN THE USUAL MANNER.

WE FOUND THE ALUMINUM PIPE SET FOR THE NORTHEAST CORNER OF THE SE1/4NW1/4SW1/4 BADLY MANGLED AND BENT FROM HEAVY EQUIPMENT USED IN ROAD CONSTRUCTION. THE ALUMINUM CAP WAS MISSING. THE BOTTOM OF THE PIPE, 25 INCHES BELOW THE ROAD SURFACE, WAS STILL IN POSITION. WE SET A 5/8 X30 INCH IRON PIN, WITH ATTACHED ALUMINUM CAP, 4 INCHES BELOW THE ROAD SURFACE AT THIS POSITION.

WE INTERSECTED THE NORTH RIGHT OF WAY LINE OF COUNTY ROAD NO. 52 AND SET IRON PINS AT THESE POINTS AS SHOWN.


