THIS SURVEY WAS PERFORMED AT THE REQUEST OF BOB BURRIL. THE PURPOSE OF THIS SURVEY WAS TO LOCATE THE PROPOSED PROPERTY ADJUSTMENT LINE SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. I MADE FIELD MEASUREMENT TO LOCATE THE FENCE LINE AND THE APPURTENANT MONUMENTS SHOWN ON RECORD MAP OF SURVEY NO. 1036, AS SHOWN HEREON.

THE IRON PIN MONUMENT FOUND AT THE INTERSECTION OF THE NORTH LINE OF THE S1/2SE1/4 AND THE COUNTY ROAD RIGHT OF WAY IS BENT BADLY. I DUG DOWN AND TIED THIS PIN AT THE SPIN-POINT. I ACCEPT THE FOUND MONUMENTS FROM RECORD SURVEY NO. 1036, AS SHOWN HEREON.

I SET NEW MONUMENTS ON THE PROPOSED PROPERTY ADJUSTMENT LINE ACCORDING TO THE EVIDENCE FOUND AND AT LOCATIONS APPROVED BY MR. BURRIL, AS SHOWN HEREON.
