

# **NARRATIVE**

THIS SURVEY WAS PERFORMED AT THE REQUEST OF PASTOR DAVID HOEFFNER. THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT THE SOUTH LINE OF LOT 12, THE NORTH LINE OF THE S1/2 OF LOT 15 AND THE NORTH LINE OF LOT 16 IN BLOCK 13 OF CLEAVER AND COZART ADDITION TO PRAIRIE CITY, AS SHOWN HEREON.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE APPURTENANT MONUMENTS SHOWN ON RECORD MAP OF SURVEY NO.'S 236, 347, 491 AND 1487. I ACCEPT THE FOUND MONUMENTS FROM THESE SURVEYS, UNLESS OTHERWISE NOTED.

MOST OF THE FOUND MONUMENTS FROM SURVEY NO. 1487 ARE WITHIN THE NORMAL TOLERANCE FOR ACCEPTANCE, HOWEVER, THE MONUMENTS ARE NOT ACCEPTED AS BEING ON THE RIGHT OF WAY LINE OF JOHNSON STREET OR THE ALLEY AND ARE SHOWN FOR INFORMATIONAL PURPOSES ONLY.

THE EAST AND WEST LINES OF BLOCK 13 AND THE ALLEY ARE PARALLEL TO THE CENTER-LINE OF JOHNSON STREET, AS SHOWN HEREON. THE NORTH LINE OF LOT 13 IS PARALLEL TO THE CENTERLINE OF THIRD STREET. THE FOUND MONUMENTS SHOWN ALONG THE NORTH RIGHT OF WAY LINE OF THIRD STREET ARE 40 FEET DISTANT AND PARALLEL TO THE CENTERLINE OF THIRD STREET, UNLESS OTHERWISE SHOWN.

I SET NEW MONUMENTS ACCORDING TO THE EVIDENCE FOUND, AS SHOWN HEREON.
