# NARRATIVE

THE PURPOSE OF THIS MAP OF SURVEY IS TO SHOW PINS THAT WERE SET FOR A PROPOSED LAND PARTITION BY LARRY REDFIELD. RECORDING OF THE LAND PARTITION PLAT HAS BEEN DELAYED. I THEREFORE FILE THIS MAP OF SURVEY TO DOCUMENT THE IRON PINS THAT I SET DURING THE SURVEY FOR THE LAND PARTITION.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. WE RETRACED RECORD SURVEY NO. 1355 WHICH I SURVEYED IN DECEMBER 1994. WE FOUND ALL THE IRON PINS OF THAT SURVEY IN POSITION, WITH THE EXCEPTION OF THE SE CORNER OF THE TRACT. THIS PIN WAS DESTROYED IN FENCING OPERATIONS. I RESET THIS CORNER IN ITS ORIGINAL POSITION AT RECORD BEARING AND DISTANCE FROM THE OTHER FOUND MONUMENTS, AS SHOWN HEREON.

THE FOUR OTHER PINS SET ON THE BOUNDARY OF THIS TRACT FOR THE LAND PARTITION ARE SET ACCORDING TO THE EVIDENCE FOUND AND AT LOCATIONS APPROVED BY MR. REDFIELD.
