

NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF BABETTE LARSON, WITH THE PURPOSE OF MONUMENTING A PROPOSED PROPERTY LINE ADJUSTMENT.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. IN SEPTEMBER OF 1969, ROBERT BAGETT, PLS PERFORMED RECORD MAP OF SURVEY NO. 148 IN WHICH HE RETRACED THE WEST LINE OF SECTION 6. HIS BEARING ALONG THIS LINE BETWEEN FOUND MONUMENTS HAS BEEN USED AS A BASIS OF BEARINGS FOR SEVERAL SURVEYS OVER THE YEARS, AND IS THE BASIS OF BEARINGS FOR THIS SURVEY. MR. BAGETT ALSO PERFORMED RECORD MAP OF SURVEY NO. 152, WHERE HE RETRACED THE SOUTH LINE OF SECTION 6 AND LOCATED A PORTION OF THE SOUTHERLY BOUNDARY OF THE GREGG PROPERTY. THE LARSON PROPERTY WAS ORIGINALLY SURVEYED BY DOUG FERGUSON, PLS, IN SEPTEMBER OF 1977, RECORDED AS MAP OF SURVEY NO. 464. I MADE FIELD MEASUREMENTS TO RECOVER CONTROLLING MONUMENTATION FROM SAID SURVEYS. I FOUND ONLY ONE REMAINING MONUMENT FROM SURVEY NO. 464 AT THE SOUTHEAST CORNER OF THE LARSON PROPERTY. I BELIEVE THE REST HAVE BEEN LOST TO FENCE BUILDING ACTIVITY. I ACCEPT THE FOUND APPURTENANT MONUMENTS FROM THESE SURVEYS, AS SHOWN HEREON.

NEW MONUMENTS WERE SET ALONG AN EXISTING FENCE LINE FOR THE PROPERTY LINE ADJUSTMENT AS AGREED UPON BY THE LANDOWNERS, AND ACCORDING TO THE EVIDENCE FOUND. I'VE PREPARED A LEGAL DESCRIPTION BASED ON THIS SURVEY IN PREPARATION FOR THE CONVEYANCE.
