
## **NARRATIVE**

THIS SURVEY WAS PERFORMED AT THE REQUEST OF TIM CLEMENS, ACTING ON BEHALF OF CAROL ARBOGAST AND GLENN AND CHARLENE PHELPS. THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT THE PROPOSED PROPERTY LINE ADJUSTMENT SHOWN HEREON. MRS. ARBOGAST'S PROPERTY IS DESCRIBED IN DEED RECORD BOOK 139, PAGE 172, RECORDS OF GRANT COUNTY, OREGON. THE DEED DESCRIBES THE PROPERTY PRIOR TO A SERIES OF PROPERTY LINE ADJUSTMENTS THAT HAVE OCCURRED OVER THE LAST SEVERAL YEARS. THE PHELPS' PROPERTY IS DESCRIBED IN DEED INSTRUMENT NO. 20060058, RECORDS OF GRANT COUNTY, OREGON

IN 2006 I CONDUCTED RECORD SURVEY NO. 1776. AT THAT TIME I LOCATED APPURTENANT MONUMENTS FROM SURVEY NO'S 966 AND 1298. I ALSO LOCATED THE CENTERLINE OF THE PENDLETON – JOHN DAY HIGHWAY (HIGHWAY 395). THIS SURVEY AND MAP ARE BASED ON SURVEY NO. 1776. I SET NEW MONUMENTS AT POSITIONS DETERMINED BY THE RESULTS OF MY SURVEY AND AT POSITIONS SHOWN TO ME BY MR. PHELPS. I ALSO PREPARED A LEGAL DESCRIPTION FOR THE TRACT OF LAND BEING CONVEYED FROM MRS. ARBOGAST TO THE PHELPS.
