

NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF BRIAN CAMPBELL ON BEHALF OF CAMPBELL CROSSING, INC. SAID CORPORATION IS THE OWNER OF THE LAND DESCRIBED IN DEED INSTRUMENT NO. 20070464, DEED BOOK 50, PAGE 211 AND PARCEL 1 OF LAND PARTITION NO. 2007-3, RECORDS OF GRANT COUNTY, OREGON. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE PROPOSED PROPERTY LINE ADJUSTMENT SHOWN HEREON.

THE NORTH LINE OF THE NW1/4 OF SECTION 22 WAS SURVEYED BY ROBERT BAGETT, PLS IN 1989 DURING SURVEY NO. 1074. AS PART OF THAT SURVEY MR. BAGETT SET MONUMENTS AT THE NORTHWEST CORNER AND N1/4 CORNER OF SECTION 22. I RECENTLY VISITED THESE CORNERS IN MY CAPACITY AS GRANT COUNTY SURVEYOR AND FOUND THE ALUMINUM CAP AT THE 1/4 CORNER MISSING. I REPLACED THE MISSING CAP WITH A 2" ALUMINUM GRANT COUNTY SURVEYOR CAP AND FILED A RECORD OF CORNER MONUMENTATION REPORT.

PARTITION PLAT NO. 2007-3 WAS PREPARED IN 2007 BY JACK WATSON. NO SURVEY WAS CONDUCTED FOR THE PARTITION PROCESS. THE SW1/4SW1/4 OF SAID SECTION 22 WAS NOT A PART OF THE PARTITION.


