THIS SURVEY WAS PERFORMED AT THE REQUEST OF NANCY CHASE WITH THE PURPOSE OF MONUMENTING A PROPOSED PROPERTY LINE ADJUSTMENT APPROVED BY ADMINISTRATIVE REVIEW BY THE GRANT COUNTY PLANNING DEPARTMENT. SEE FILE NO. PLA-16-04.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE CONTROLLING MONUMENTS FROM RECORD MAP OF SURVEY NO. 956 AND LAND PARTITION PLAT NO.'S 97-33 AND 2006-06. ONE OF THE MONUMENTS FROM SURVEY NO. 956 WAS FOUND OUT OF POSITION, AND WAS NOT ACCEPTED. I ACCEPT ALL OTHER MONUMENTS FOUND DURING THE COURSE OF THIS SURVEY.


NEW MONUMENTS WERE SET AT POSITIONS ACCORDING TO THE EVIDENCE FOUND, AND AS APPROVED BY MS. CHASE AND MR. AND MRS. SAGERT. THE EAST LINE OF THIS PROPERTY LINE ADJUSTMENT IS ALONG THE WEST LINE OF THE UTILITY EASEMENT DESCRIBED IN DEED BOOK 51, PAGE 99, WHICH WAS DETERMINED BY MEASURING 15 FEET PERPENDICULAR FROM THE EXISTING OVERHEAD POWER LINE.
