

NARRATIVE

THIS SURVEY WAS EXECUTED FOR THE PURPOSE OF REESTABLISHING THE OBLITERATED MONUMENT AT THE N1/4 CORNER OF SECTION 5, T.13S., R.27E., W.M. DURING THE COURSE OF A CORNER MAINTENANCE SURVEY, WE FOUND THIS IRON PIPE MONUMENT DISTURBED

THE N1/4 CORNER WAS ORIGINALLY SET BY JOHN B. DAVID, U.S. DEPUTY SURVEYOR FOR THE GENERAL LAND OFFICE UNDER CONTRACT NO. 131, DATED JUNE 8, 1869. IN 1914, COUNTY SURVEYOR VERNON GLAZE PERPETUATED THIS CORNER POSITION BY SETTING AN IRON PIPE WITH ATTACHED BRASS CAP. AS WAS COMMON PRACTICE FOR BOTH SURVEYS, NO CORNER ACCESSORIES WERE SET FOR THIS CORNER

IN NOVEMBER 2005, JACK WATSON LOCATED THIS CORNER AS PART OF RECORD SURVEY NO. 1745. HIS MAP SHOWS THE RELATIONSHIPS BETWEEN THE SUBJECT CORNER AND THE FOUND MONUMENT AT THE NORTHEAST CORNER AND THE MONUMENT HE SET AT THE S1/4 CORNER OF SAID SECTION 5.

UPON OUR INITIAL VISIT TO THIS CORNER, WE FOUND IT BENT TO NEARLY 90 DEGREES AND LYING FLUSH WITH THE GROUND. TO REESTABLISH THIS CORNER IN ITS POSITION AS REPORTED ON RECORD MAP OF SURVEY NO. 1745, WE USED A DISTANCE-DISTANCE INTERSECTION UTILIZING THE RECORD DISTANCES FROM THE FOUND MONUMENTS AT THE NORTHEAST CORNER AND S1/4 CORNER OF SECTION 5, AS SHOWN HEREON.

I HAVE FILED RECORDS OF LAND CORNER MONUMENTATION SHEETS FOR EACH OF THE CORNERS SHOWN HEREON. THE MONUMENTATION SHEETS DESCRIBE IN DETAIL THE CONDITION OF EACH MONUMENT AND ACCESSORIES FOUND OR SET AS PART OF THIS SURVEY
