## NARRATIVE

THE PURPOSE OF THIS SURVEY IS TO RESOLVE THE EXISTING RIGHT OF WAY CENTER LINE AND RETRACE THE EXISTING RIGHT OF WAY MARGINS FOR A PORTION OF JOHN DAY - BURNS HIGHWAY (US395) FROM SW 4TH AVENUE SOUTHERLY TO THE SOUTHERLY BOUNDARY OF THE GRANT UNION HIGH SCHOOL PROPERTY, AND SW 4TH AVENUE FROM THE JOHN DAY - BURNS HIGHWAY SOUTHERLY TO SW BRENT DRIVE. THIS SURVEY IS ALSO TO PERPERTUATE THOSE SURVEY MONUMENTS IN JEOPARDY OF BEING DESTROYED BY A FUTURE SIDEWALK CONSTRUCTION PROJECT TO BE INSTALLED ON THE SOUTHWESTERLY SIDE OF THE HIGHWAY. THIS SURVEY MEETS THE REQUIREMENTS FOR A RECOVERY SURVEY AS OUTLINED IN THE OREGON REVISED STATUTES, SECTION 209.155.

THIS SURVEY WAS PERFORMED IN INTERNATIONAL FEET UNITS. THIS SURVEY WAS PERFORMED BETWEEN THE MONTHS OF NOVEMBER 2016 AND JANUARY 2017. THE SURVEY EQUIPMENT USED CONSISTED OF LEICA GS-14 RECEIVERS. A LEICA MS-50 TOTAL STATION, AND LEICA VIVA SURVEY CONTROLLERS.

#### JOHN DAY - BURNS HIGHWAY (US395) (S. CANYON CITY BLVD.)

THE CENTER LINE FOR THE JOHN DAY-BURNS HIGHWAY WAS RECREATED AS SHOWN ON ODOT DRAWING 88-3-31 AND MAP OF SURVEY NO. 1129, AND WAS POSITIONED BY HOLDING RECORD DISTANCES SHOWN ON SAID SURVEY 1129 TO THE CENTER LINE MONUMENTS FOUND AT POINTS 1003 & 1004. THE RECORD SHAPE OF SAID CENTER LINE ALIGNMENT DID NOT FIT WITH THE ORIGINAL HIGHWAY RIGHT OF WAY MONUMENT FOUND AT POINTS 1021 AND 1035. THEREFORE THE TANGENT 40.00 FEET LEFT OF POINT 1035 AND 42.00 FOOT RIGHT OF POINT 1038 WAS HELD AND EXTENDED NORTHERLY TO INTERSECT THE FORWARD TANGENT. RECORD DEGREE OF CURVE WAS HELD TO RE-ESTABLISH THE CURVES. THE RESULTING RESOLVED CENTER LINE ALIGNMENT FITS VERY WELL WITH MONUMETATION AND LINES OF OCCUPATION RECOVERED ALONG THIS PORTION OF JOHN DAY - BURNS HIGHWAY. THE RIGHT OF WAY WIDTHS WERE BASED UPON ODOT DRAWING 8B-3-31. STATIONING SHOWN ON THE ODOT ROLLMAPS WAS TO THE NEAREST TENTH OF A FOOT, THEREFORE THE ERROR IN HUNDREDTHS OF A FOOT IN STATIONING WAS PRORATED BETWEEN THE MONUMENTS FOUND AT POINTS 1006 AND 1021.

### SW 4TH AVENUE (HALL STREET) "L" LINE

THE CENTER LINE FOR SW 4TH AVENUE WAS RECREATED AS SHOWN ON MAP OF SURVEY 1129 AND POSITIONED BY HOLDING MONUMENTS SET ON SAID MAP OF SURVEY 1129 AT THE INTERSECTION OF SW 4TH AVENUE WITH THE SOUTHERLY RIGHT OF WAY OF JOHN DAY BURNS HIGHWAY (POINT 1002) AND AT THE INTERSECTION OF SW 4TH AVENUE WITH SW BRENT STREET. THE RIGHT OF WAY FOR SW 4TH AVENUE WAS CREATED BY DEDICATION PER THE PLAT OF BRENT ADDITION TO JOHN DAY AT A WIDTH OF 50 FEET, 25 FEET EITHER SIDE OF CENTER LINE, STATIONING FOR SW 4TH AVENUE WAS ESTABLISHED PER THIS SURVEY.
