## **NARRATIVE**


THIS SURVEY WAS PERFORMED AT THE REQUEST OF BOB TITUS, OWNER OF THE LAND DESCRIBED IN DEED INSTRUMENT NO. 950529, DEED RECORDS OF GRANT COUNTY, OREGON THE PURPOSE OF THIS SURVEY WAS TO LOCATE AND MONUMENT THE NORTHWEST CORNER OF THE TITUS' PROPERTY AND TO POST WITH LATH AND FLAGGING THE NORTH LINE OF THE PROPERTY.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. I FOUND RECORD MAP OF SURVEY NO'S 113, 1370, 1910, 1912 AND 1918 AND LAND PARTITION PLAT NO.'S 96-20 AND 97-02. I ACCEPT THE FOUND MONUMENTS SHOWN HEREON.

THE NORTHWEST CORNER TO THE TITUS' TRACT IS ALSO THE NW1/16 CORNER OF SECTION 2, T.13S, R.33E., WM I UTILIZED THE FOUND MONUMENTS SHOWN HEREON, THE SUBDIVISION OF SAID SECTION 2 AS DEPICTED ON RECORD MAP OF SURVEY NO. 1918 AND THE 2009 BLM MANUAL OF SURVEYING INSTRUCTIONS TO DETERMINE THE LOCATION OF THE NW1/16 CORNER. SEE THE RECORD OF CORNER MONUMENTATION FILED IN CONJUNCTION WITH THIS MAP IN THE OFFICE OF THE GRANT COUNTY SURVEYOR FOR ADDITIONAL DETAILS ON THIS CORNER AND ITS ACCESSORIES.





