A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. COUNTY SURVEYOR RECORDS SHOW THAT THE SUBJECT PROPERTY WAS ORIGINALLY SURVEYED IN 1979 BY ROBERT BAGETT, PLS. HIS MAP IS RECORDED AS RECORD MAP OF SURVEY NO. 565. I ALSO FOUND RECORD SURVEY NO. 1886 BY JACK WATSON CONDUCTED IN DECEMBER 2009. MR. WATSON'S SURVEY IS A TRACT LYING WEST OF AND ADJACENT TO A PORTION OF THE WEST BOUNDARY LINE OF THE PROPERTY SHOWN HEREON.

I ACCEPT THE FOUND MONUMENTS FROM SURVEY NO. 565. I ALSO ACCEPT THE FOUND MONUMENT FROM SURVEY NO. 1886 LOCATED ON THE NORTH HIGHWAY RIGHT OF WAY LINE AND AT THE SOUTHWEST CORNER OF THE PROPERTY BEING SURVEYED HEREON

I SEARCHED FOR, BUT DID NOT FIND THE NORTHWEST CORNER OF THE MEADOWBROOK TRACT. IT APPEARS THAT THIS CORNER MAY HAVE BEEN DESTROYED DURING THE PAVING OF THE PARKING LOT. I SET THE MISSING CORNER AT RECORD BEARING AND DISTANCE FROM THE FOUND PIN ON THE BOUNDARY OF THE SUBJECT TRACT AND AT RECORD DISTANCE FROM THE FOUND PIN ON THE HIGHWAY RIGHT OF WAY LINE. THE OTHER FOUND PIN FROM SURVEY NO. 1886 MAY BE DISTURBED. IT FALLS IN THE GRAVEL ADJACENT TO A DRIVEWAY AND SEEMS TO BE BENT. I DO NOT ACCEPT THIS PIN AS BEING ON THE BOUNDARY OF THE SUBJECT TRACT.


