

## NARRATIVE

THIS SURVEY WAS CONDUCTED AT THE REQUEST OF MIKE DAVIS, OWNER OF THE LAND DESCRIBED IN DEED INSTRUMENT NO. 20181285, DEED RECORDS OF GRANT COUNTY, OREGON. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE CORNERS OF LOT 3, BLOCK 10 OF SENECA.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. SENECA WAS PLATTED IN 1930 BY M.D. HALEY. IN 1974, MARC PALMER, PLS, SET MONUMENTS ALONG THIRD STREET AT CENTERLINE INTERSECTIONS WITH INTERSECTING STREETS. PALMER'S MAP IS RECORDED AS MAP OF SURVEY NO. 342. IN 1978, MR. PALMER PERFORMED RECORD MAP OF SURVEY NO. 496, WHICH A RETRACEMENT OF THE ENTIRE SENECA SUBDIVISION. DURING THE COURSE OF HIS SURVEY OF THE SUBDIVISION, HE MONUMENTED ALMOST ALL OF THE BLOCK CORNERS.

RECORD SURVEY NO. 1974 WAS CONDUCTED BY JASON HATFIELD, PLS IN MARCH, 2013. DURING HIS SURVEY MR. HATFIELD UTILIZED RECORD INFORMATION AND FOUND MONUMENTS FROM THE AFOREMENTIONED SURVEYS TO DETERMINE THE CORNERS OF BLOCK 16. I PERFORMED SURVEY NO. 2015 IN NOVEMBER 2014. DURING THAT SURVEY I ESTABLISHED THE CORNERS OF LOT 4, BLOCK 9 OF SENECA. I ALSO PERFORMED SURVEY NO. 2060 IN 2016 WHICH WAS A REPLAT OF LOTS 9, 10 AND 11 OF BLOCK 16 OF SENECA.

I BEGAN THIS SURVEY BY LOCATING APPURTENANT CONTROLLING SURVEY MONUMENTS FROM THE SURVEYS DISCUSSED HEREIN. I ACCEPT THE FOUND MONUMENTS SET DURING SURVEY NO. 1974, 2015, 2060 AND THE NORTHEAST CORNER OF BLOCK 9 FROM SURVEY NO. 496. I ALSO ACCEPT AND UTILIZE THE CALCULATED POSITION OF THE SOUTHEAST CORNER OF BLOCK 9 FROM SURVEY NO. 2015. I SET NEW MONUMENTS AT THE FOUR CORNERS OF SAID LOT 3 BY PROPORTIONATE MEASURE BETWEEN CONTROLLING CORNERS SHOWN HEREON.
