THIS SURVEY WAS CONDUCTED AT THE REQUEST OF JEFF RIGGS. THE PURPOSE OF THIS SURVEY WAS TO MONUMENT THE ADJUSTED PROPERTY LINE AS DESCRIBED IN DEED INSTRUMENT NO. 20211731, DEED RECORDS OF GRANT COUNTY, OREGON.

A SEARCH WAS MADE OF AVAILABLE RECORDS. I FOUND LAND PARTITION PLAT NO. 2006-02 AND RECORD MAP OF SURVEY NO'S 1617, 1790 & 1811. THE FOUND MONUMENTS SHOWN HEREON FROM THESE SURVEYS ARE


THE POSITION FOR THE S1/4 CORNER SECTION 10 IS CALCULATED AT THE MIDPOINT BETWEEN THE FOUND MONUMENTS AT THE SOUTHWEST AND SOUTHEAST SECTION CORNERS. NO MONUMENT IS SET AT THE LOCATION OF THE S1/4 CORNER AS THE CALCULATED POSITION FALLS IN AN EXISTING ROAD WAY.

I SET THE E1/4 CORNER OF SECTION 10 AT THE MIDPOINT BETWEEN FOUND MONUMENTS AT THE NORTHEAST AND SOUTHEAST SECTION CORNERS. THE REMAINING PINS WERE SET ACCORDING TO THE EVIDENCE FOUND AND AS DESCRIBED IN THE DEED DESCRIPTION. GOD BLESS AMERICA.


