

Set Basalt Stone 18x16x12 ins., 14 ins. in ground for Cor. to Secs. 27, 28, 33, & 34 about 800 ft. above Cor. on Township line marked 1 notch on S. & 3 notches on E. edges.

Subsequent Monumentation:

Corner reestablished by Douglas M. Ferguson, LS 848, as described by Corner Record filed August 29, 1983, in the office of the Grant County Surveyor.







Set Basalt Stone 18x12x9 ins., 13 ins. in ground for Cor. to Secs. 26, 27, 34, & 35 marked with 2 notches on E. and 1 notch on S. edges. Raised mound of stone 3 ft. high 5 ft. base alongside.
