

THE PURPOSE OF THIS PROJECT WAS TO SUBDIVIDE A PORTION PARCEL 1 OF LAND PARTITION PLAT NO. 2006-02 AND TO CREATE THE EXTENSION OF CHAROLAIS DRIVE.


A SEARCH WAS MADE OF AVAILABLE RECORDS, I FOUND LAND PARTITION PLAT NO.'S 2006-02 AND 2015-04 AND RECORD MAP OF SURVEY NO'S 190, 583, 1032, 1140, 1559 AND 1864. WE LOCATED THE APPURTENANT CONTROLLING RECORD MONUMENTS SHOWN ON THE ANNEXED MAP. FOUND MONUMENTS SHOWN ON THE ANNEXED PLAT WERE ACCEPTED.

SEVERAL PINS ALONG THE SOUTHERLY RIGHT OF WAY LINE OF CHAROLAIS DRIVE HAD BEEN DESTROYED OVER THE YEARS, OTHER PINS WERE BURIED UNDER SEVERAL FEET IF FILL DIRT FROM RECENT ROAD CONSTRUCTION ACTIVITIES. THE NORTHWEST CORNER OF PARCEL 2, LAND PARTITION PLAT 2006-02 WAS REPLACED BY INTERSECTING THE RECORD BEARINGS FROM THE NORTHEAST AND SOUTHWEST CORNERS OF SAID PARCEL 2. THE NORTHEAST CORNER OF THE STODDARD TRACT WAS REPLACED BY HOLDING THE RECORD BEARING AND DISTANCE FROM THE FOUND PIN AT THE SOUTHEAST CORNER OF EXISTING CHAROLAIS DRIVE FROM SURVEY NO. 1032. THE NORTHWEST AND SOUTHWEST CORNERS OF TRACT "A" WERE PLACED BY GIVING THE 50 FOOT STRIP ADJACENT TO AND WESTERLY OF TRACT "A" ITS FULL RECORD WIDTH OF 50 FEET.
