NARRATIVE

THIS SURVEY WAS CONDUCTED AT THE REQUEST OF NIKKI MANTEI, ON BEHALF OF HERSELF AND DENNIS MANTEI, OWNERS OF THE LAND DESCRIBED IN DEED RECORD INSTRUMENT NO.'S 20200288 AND 20211841, DEED RECORDS OF GRANT COUNTY, OREGON. THE PURPOSE OF THIS PROJECT WAS TO SURVEY AND MONUMENT THE BOUNDARIES OF SAID TRACTS WHICH ARE LOCATED IN LOT 1, BLOCK E, JOHN DAY.

A SEARCH WAS MADE OF AVAILABLE RECORDS, WE MADE FIELD MEASUREMENTS TO LOCATE THE EXISTING MONUMENTS FROM SURVEY NO'S 1008, 1876, 2041 AND 2042. THESE MONUMENTS ARE ACCEPTED AND USED AS CONTROL FOR THIS SURVEY.

MUCH OF BLOCK E WAS SURVEYED IN 2009 BY JASON HATFIELD, PLS. HIS MAP IS RECORDED AS SURVEY NO. 1876. IN 2015, MR. HATFIELD CONDUCTED SURVEY NO'S 2041 AND 2042, ALSO IN BLOCK E. I HELD HATFIELD'S RESOLUTION FOR LOTS 1, 2 AND 3 IN SAID BLOCK E. IN ORDER TO RESOLVE THE BOUNDARIES OF THE MANTEIS' TRACTS, I DETERMINED THE JUNIOR/SENIOR RIGHTS OF THE MANTEIS' AND THE ESTES' PROPERTIES, ALL OF WHICH ARE LOCATED IN SAID LOT 1. RESEARCH SHOWED THAT THE ESTES' TRACT AND THE MANTEIS' TRACT DESCRIBED IN DEED INSTRUMENT NO. 20200288 HAVE SENIOR STATUS OVER THE MANTEIS' LAND DESCRIBED IN DEED INSTRUMENT NO. 20211841. I GAVE THE TWO SENIOR TRACTS THEIR FULL DEED RECORD DISTANCES ALONG THE NORTH AND SOUTH LINES OF SAID TRACTS. THE LAND DESCRIBED IN DEED INSTRUMENT NO. 20211841 RECEIVED THE REMAINDER OF LAND IN LOT 1. AS INDICATED HEREON, THE BUILDING LOCATED ON THE WEST SIDE OF THE ESTES' TRACT ENCROACHES ONTO MANTEIS' BY APPROXIMATELY 0.8 FEET.

WE MARKED THE CORNERS OF THE SUBJECT PROPERTY IN ACCORDANCE WITH THE DEED DESCRIPTIONS AND PER THE EVIDENCE FOUND. GOD BLESS AMERICA.
