



SURVEY NARRATIVE

WE WERE EMPLOYED BY TOM HOSKINGS TO COMPLETE A PARTIAL BOUNDARY SURVEY OF HIS PROPERTY. THE INTENT OF THIS SURVEY IS TO PERFORM A SURVEY OF A PORTION OF HIS WEST PROPERTY LINE AS SURVEYED DURING MAP OF SURVEY NO. 660 BY ROBERT D. BAGETT. SEARCH IN THE FIELD RECORVERED THE NORTHWEST CORNER OF SECTION 13 AND THE THREE MONUMENTS SET DURING SAID SURVEY ALONG SUBJECT PROPERTIES NORTH LINE. I COMPUTED THE NORTHWEST CORNER OF SUBJECT PROPERTY FROM THE REFERENCE MONUMENT SET DURING SURVEY NO. 660. ALL BEARINGS AND DISTANCES FIT PERFECTLY BETWEEN THE SECTION CORNER TIE AND SAID COUMPUTED NORTHWEST CORNER SO I HELD RECORD BEARING AND DISTANCES FOR THIS SURVEY. RECORD MAP OF SURVEY NO. 239 STATES THAT CORNER POSITIONS ALONG THIS SURVEYED LINE ARE "LIVE JUNIPERS TREES TO WHICH THE FENCE IS ATTACHED". THESE TREES HAVE BEEN CUT DOWN. WE WERE ABLE TO SET THE TRUE CORNER LOCATION UP NEXT TO THE STUMPS ON ALL OF THE CORNERS EXCEPT ONE. WE SET REFERENCE MONUMENTS TO THIS CORNER AS SHOWN ON DETAIL 2. THE MOST SOUTHERLY CORNER SET DURING THIS SURVEY IS A REFERENCE MONUMENT AS THE CORNER LOCATION FALLS ON THE NORTH LINE OF THE SW1/4 NW1/4 OF SECTION 13. WE DID NOT MAKE AN ATTEMPT TO SURVEY THE LOCATION OF SAID LINE. BASIS OF BEARINGS IS ALONG THE LINE FROM THE NORTHWEST CORNER OF SECTION 13 AS SHOWN ON THE PLAT DRAWING. THIS SURVEY WAS PERFORMED USING A TRIMBLE R12 GPS SYSTEM IN
