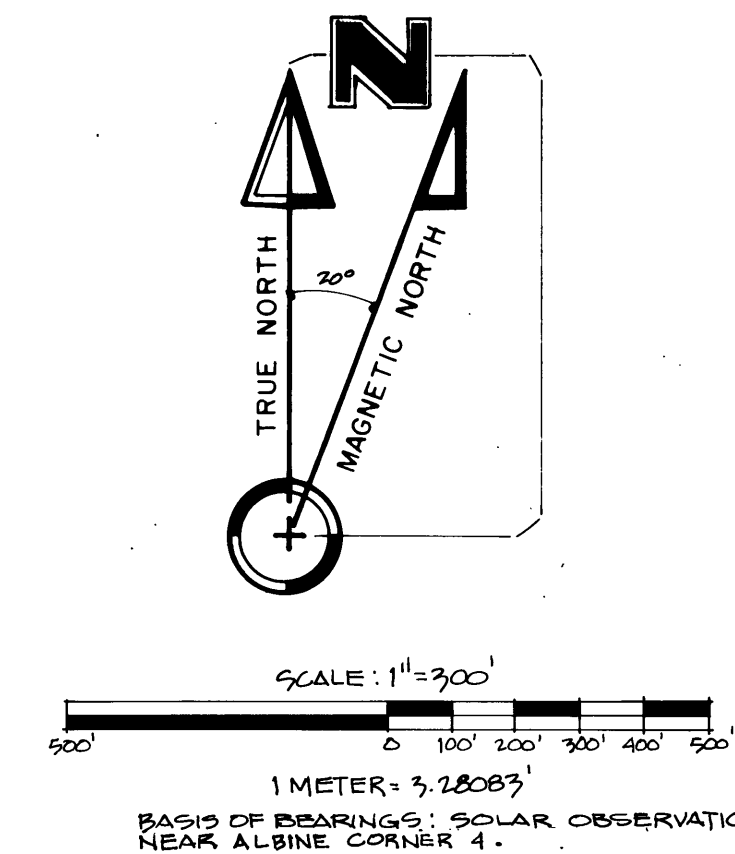


**PLAT OF MS 477 AND PART OF MS 421**

**HISTORY OF SURVEYS**

MS 477 WAS ORIGINALLY SURVEYED BY ARTHUR PHILBRICK, US DEPUTY MINERAL SURVEYOR, FOR THE BALD MOUNTAIN GOLD MINING COMPANY IN JUNE AND JULY, 1902. MS 421 WAS ORIGINALLY SURVEYED BY CHAS. M. FOSTER, US DEPUTY MINERAL SURVEYOR, FOR ARTHUR HILL, IN AUGUST, 1901.

**NARRATIVE OF SURVEY**

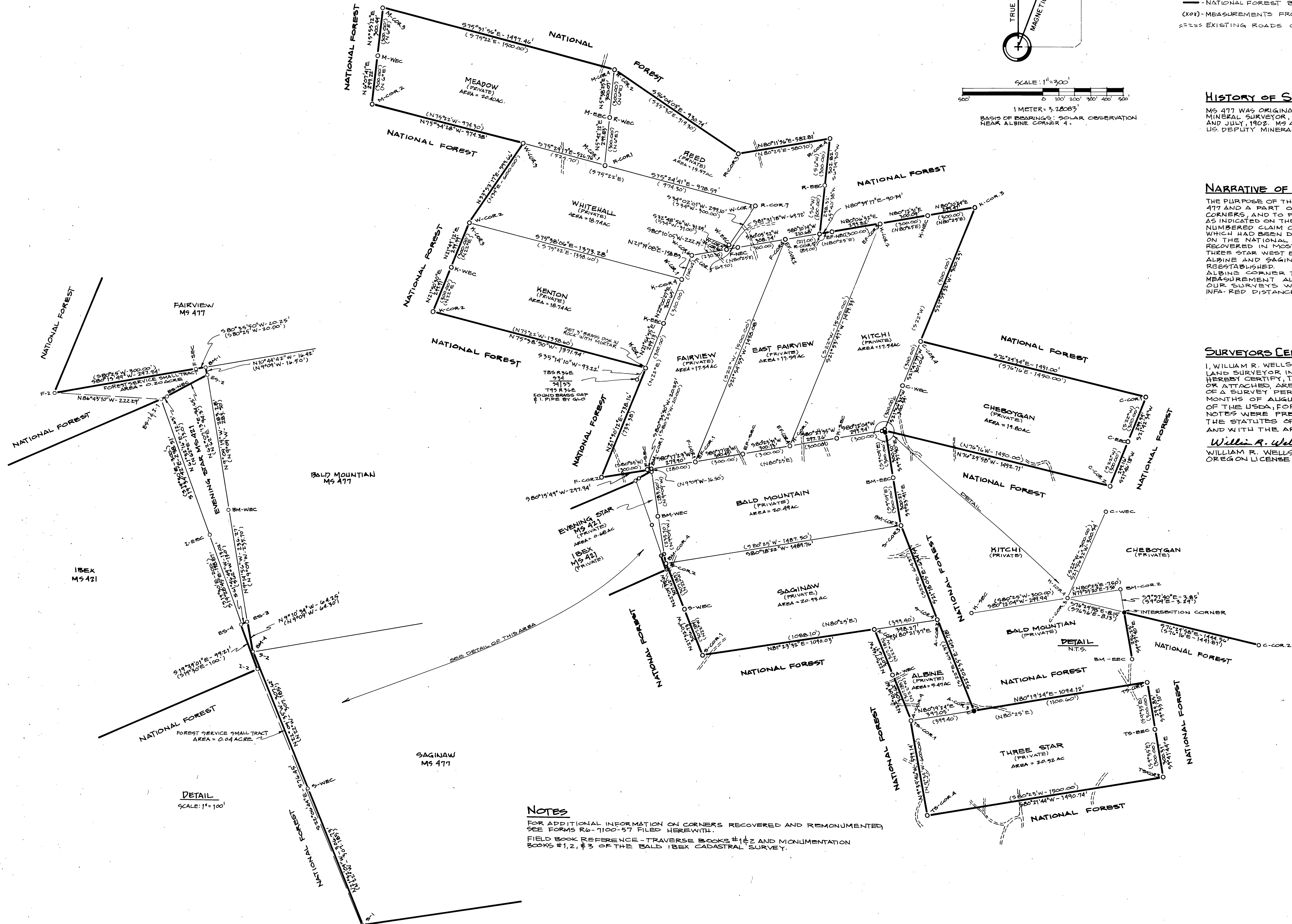
THE PURPOSE OF THIS SURVEY WAS TO RETRACE THE BOUNDARIES OF MS 477 AND A PART OF MS 421, TO RECOVER AND REMONUMENT ORIGINAL CORNERS, AND TO POST THE PRESENT NATIONAL FOREST BOUNDARY, AS INDICATED ON THE PLAT, ACCEPTABLE ORIGINAL EVIDENCE FOR ALL NUMBERED CLAIM CORNERS WAS FOUND, EXCEPT FOR ALBINE CORNER 3, WHICH HAD BEEN DESTROYED BY ROAD CONSTRUCTION. END CENTERS ON THE NATIONAL FOREST BOUNDARY WERE SEARCHED AND WERE RECOVERED IN MOST CASES. THE WHITEHALL WEST END CENTER, THREE STAR WEST END CENTER, AND THE EAST END CENTERS OF ALBINE AND SAGINAW WERE NOT RECOVERED AND WERE NOT REESTABLISHED. ALBINE CORNER 3 WAS REESTABLISHED BY SINGLE PROPORTION MEASUREMENT ALONG THE NORTH LINE OF THE THREE STAR CLAIM. OUR SURVEYS WERE MADE WITH A 1 SECOND THEODOLITE AND INFA-RED DISTANCE MEASURING EQUIPMENT.
