DECLARATION

Know all people by these present that I, Charles J. Stinnett, do hereby declare I am the owner of the lands described in the Surveyor's Certificate, and that I have caused the same to be partitioned into parcels in accordance with the provisions of ORS Chapter 92

SAID PARCELS ARE SUBJECT TO THE FOLLOWING:

NARRATIVE

This survey was performed at the request of Charlie Stinnett. The purpose of this survey was to partition parcel 1 of Land Partition No. 99-13 into 2 parcels. Parcel 1 of this land partition was not surveyed. Parcel 2 of this partition is surveyed and the corners monumented.

After searching the available records pertaining to this survey, I found Land Partition Plat No. 98-42, dated December 14, 1998 and Land Partition Plat No.99-13, dated May 3, 1999. County Road No. 78, Deed Instrument No. 220170, was used for the north and east boundary. The south boundary is at the location approved by Mr. Stinnett. I find no record of a Geodetic Control Monument within 1/2 mile of this partition.
