SITUATED IN THE NORTHWEST 1/4 & THE SOUTHWEST 1/4 OF SEC. 23, T.135., R.31E., W.M.

SURVEYOR'S NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF THE CITY OF JOHN DAY FOR THE PURPOSE OF PARTITIONING THIS PROPERTY AS SHOWN HEREON, THE LOCATION AND SIZE OF PARCEL 2 WAS DETERMINED BY REPRESENTATIVES OF THE CITY OF JOHN DAY. PARCEL 2 IS INTENDED TO BE USED AS A WELL SITE FOR THE CITY OF JOHN DAY WATER SYSTEM. THE WESTERN BOUNDARY LINE OF PARCEL 2 WAS DERIVED FROM THE RECOVERY OF EXISTING MONUMENTS FROM GRANT COUNTY SURVEY NO. 405. THE MONUMENT MARKING THE NORTHEAST CORNER OF SURVEY NO. 405 WAS SEARCHED FOR BUT NOT FOUND, A WOODEN FENCE POST HAS BEEN PLACED IN THIS LOCATION. THE MONUMENT APPEARS TO HAVE BEEN OBLITERATED. A FOUND MONUMENT FROM GRANT COUNTY SURVEY NO. 429 ALONG WITH FOUND MONUMENTS FROM SURVEY NO. 405 FIT WELL WITH RECORD CALLS AND THE COMPUTED POSITION OF THE NORTHEAST CORNER OF SURVEY NO. 405. THE SOUTHERN BOUNDARY LINE OF PARCEL 2 WAS LOCATED FROM THE EXISTING MONUMENT AT THE SOUTHEAST CORNER OF SURVEY NO. 405. THE RECORD BEARING FROM SURVEY NO. 405 WAS PROJECTED ALONG THE NORTHERN BOUNDARY OF TROWBRIDGE SUBDIVISION AND INTERSECTED WITH THE EASTERN BOUNDARY OF PARCEL 2. PARCEL I CONTAINS MORE THAN IO ACRES AND WAS NOT FULLY RETRACED OR MONUMENTED. IT IS AN UNSURVEYED REMAINDER PARCEL, IN ACCORDANCE WITH O.R.S. CHAPTER 92 REGULATIONS. NO APPARENT CONFLICTS BETWEEN RECORD DATA AND MEASURED DATA WERE NOTED. TWO TRIMBLE 4000 SSI RECEIVERS IN REAL TIME KINEMATIC MODE AND A TOPCON 802A ROBOTIC TOTAL STATION WERE USED IN THIS SURVEY.

THE BASIS OF BEARING OF THIS PLAT IS DERIVED FROM GRANT COUNTY LAND PARTITION PLAT NO. 92-2 AS SHOWN HEREON.
