

SURVEYOR'S NARRATIVE

THIS SURVEY WAS PERFORMED AT THE REQUEST OF THE CITY OF JOHN DAY FOR THE PURPOSE OF PARTITIONING THIS PROPERTY AS SHOWN HEREON. THE LOCATION AND SIZE OF PARCEL 2 WAS DETERMINED BY REPRESENTATIVES OF THE CITY OF JOHN DAY. PARCEL 2 IS INTENDED TO BE USED AS A WATER RESERVOIR SITE FOR THE CITY OF JOHN DAY WATER SYSTEM. THE WESTERN BOUNDARY LINE OF PARCEL 2 WAS ESTABLISHED FROM THE RECOVERY OF EXISTING MONUMENTS SHOWN ON GRANT COUNTY SURVEY NO. 372 AND COUNTRY CLUB ESTATES. THE FOUND LOCATIONS OF THESE MONUMENTS FIT WELL WITH RECORD CALLS. THE NORTHERN, EASTERN AND SOUTHERN BOUNDARY LINES OF PARCEL 2 WERE ESTABLISHED TO CREATE A ONE ACRE PARCEL WITH ACCESS ALONG LA COSTA DRIVE AS SHOWN. PARCEL I CONTAINS MORE THAN 10 ACRES AND WAS NOT FULLY RETRACED OR MONUMENTED, IT IS AN UNSURVEYED REMAINDER PARCEL, IN ACCORDANCE WITH O.R.S. CHAPTER 92 REGULATIONS. NO APPARENT CONFLICTS BETWEEN RECORD DATA AND MEASURED DATA WERE NOTED. TWO TRIMBLE 4000 SSI RECEIVERS IN REAL TIME KINEMATIC MODE AND A TOPCON 802A ROBOTIC TOTAL STATION WERE USED IN THIS SURVEY.

THE BASIS OF BEARING OF THIS PLAT IS DERIVED FROM COUNTRY CLUB ESTATES SUBDIVISION AS SHOWN HEREON.
