NARRATIVE

This survey was performed at the request of Dean Rogers. The purpose of this survey was to partition the property described in Instrument No. 981073, into 3 parcels.

A was made of the available records and field measurements were made to locate four corners of the NE1/4 of Section 32, the access road, underground utilities, spring and water tank. I accepted the monuments at the four corners of the NE1/4 of Section 32. New monuments were set at locations pointed out to me by the clients to establish the boundaries of Parcels 2 and 3. The bearings for this survey are based on the south line of Parcel 1 which is shown on Survey No. 1482.

EASEMENTS
