


NARRATIVE

This survey was performed at the request of Bill Powell. The purpose of this survey was to partition the property, into 2 parcels.

A search was made of the available records pertaining to this survey. Field measurements were made to locate the existing monuments and the improvements along the highway from Main Street to Parcel 1. The highway right of way is located by using the record bearing from the monument found on the westerly right of way line. I held the deed record distance from the northeast corner of Lot 1, Block 1 of Keeney's Addition to the southeast corner of Parcel 2 and the deed record dimensions to place the lines of these parcels.



Thence N89'14'00"W, 180.00 feet;

Thence S00°39'00"W, 180.00 feet; Thence S89°14'00"E, 180.00 feet to the point of beginning.
