
### SURVEYOR'S CERTIFICATE

I, Jack L. Watson, Professional Land Surveyor, registered in the State of Oregon, hereby certify that I have correctly surveyed and marked with proper monuments the corners of Parcels 1 and 2 of this land partition. This is a partition of Tract 55, West Bench Partition, situated in the NW1/4 of Section 27, T13S, R31E, W.M., Grant County, Oregon, described as follows:

Beginning at the Initial Point of this land partition which is monumented by a 5/8" iron pin with attached red plastic cap marked "CORNERSTONE SURVEYING INC" said point being the NE corner of the NW1/4NW1/4 of Section 27, T13S, R31E, W.M.; Thence S00°46'11"W, 650.22 feet to a 5/8" iron pin on the northerly right of way line of County Road No. 74-B; Thence along the northerly right of way line of County Road No. 74-B as follows: S25°17'21"W, 91.06 feet; Thence 96.78 feet along the arc of a 100.22 foot radius curve right, the long chord of which bears (S52°57'11"W, 93.06 feet); Thence S80°37'00"W, 653.86 feet; Thence N82°03'38"W, 239.19 feet; Thence leaving said right of way line, N01°30'41"E, 852.77 feet to the north line of said Section 27; Thence N89°26'12"E, along the north line of said Section 27, 981.47 feet to the point of beginning.

#### **NARRATIVE**

This survey was performed at the request of Tina Lippert on behalf of Chester and Wanda Day. The purpose of this survey was to partition the property described in Instrument No. 922108, deeds of Grant County, Oregon, into 2 parcels.

A search of the available records pertaining to this survey was made. Field measurements were made to locate the existing monuments and to establish the new corner monuments. Survey No. 324 of the West Bench Partition created this tract and designated it Tract 55. I found and accepted the SE and SW offset monuments of Tract 55. The right of way for County Road No. 74—B was monumented in Survey No.'s 1039 and 1233. I found and accepted the right of way monuments as shown.

I found and accepted the monuments at the NW corner and N1/4 corner of Section 27. I established the NE corner of this partition on the section line and at the midpoint between the NW section corner and the N1/4 section corner. During Survey No. 844 the NW corner of this partition was established, I found and accepted the corner pin.

The division line was established at the location approved by Mrs. Lippert.
