I, ROBERT D. BAGETT, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE LAND REPRESENTED AS SHOWN ON THIS PARTITION PLAT, SAID LAND BEING SITUATED IN THE TOWN OF CANYON CITY, GRANT COUNTY, OREGON, DESCRIBED AS FOLLOWS:

## **NARRATIVE**

THIS SURVEY WAS PERFORMED AT THE REQUEST OF LAURIE TUREMAN. THE PURPOSE OF THIS SURVEY WAS TO CREATE 3 PARCELS WITH THIS LAND PARTITION, AND TO SET MONUMENTS AT THE CORNERS OF THE PARCEL BOUNDARIES AS SHOWN.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING CONTROLLING MONUMENTS. WE RETRACED THE APPURTENANT MONUMENTS FROM RECORD MAP OF SURVEY NO.'S 272 AND 692, WHICH I SURVEYED IN JULY 1972 AND AUGUST 1981, RESPECTIVELY. I ACCEPT THESE MONUMENTS, UNLESS OTHERWISE SHOWN.

WE SEARCHED FOR BUT DID NOT FIND ONE OF THE RECORD PINS FROM MAP OF SURVEY NO. 692, WHICH IS AN ANGLE POINT ON TUREMAN'S EAST BOUNDARY. I REESTABLISHED THIS CORNER PROPORTIONATELY, AS SHOWN.

NEW MONUMENTS WERE SET IN ACCORDANCE WITH THE EVIDENCE FOUND AND AT POSITIONS APPROVED BY LAURIE TUREMAN. THE DIVISION LINE BETWEEN PARCELS 1 AND 2 AND BETWEEN PARCELS 1 AND 3 IS ALONG THE RECORD CENTERLINE OF THAT CERTAIN EASEMENT DESCRIBED IN BOOK 125, PAGE 410, GRANT COUNTY DEED RECORDS, AS SHOWN ON THE MAP.
