NARRATIVE

This survey was performed at the request of Tom Campbell, on behalf of Campbell Livestock Company. The purpose of this survey was partition the property shown into three parcels. Parcel 1 was surveyed and Parcels 2 and 3 were not surveyed for this partition.

This survey was performed using static GPS receivers and Electronic Total Station. The bearings for this survey are based on the GPS survey. The GPS survey was made in NAD 83 state plane coordinates, Oregon north zone. The state plane bearings were rotated clockwise 00°39'13" to true north. All bearings are relative to this local north meridian.

A search was made of the available records pertaining to this survey. Field measurements were made to locate the E1/4 corner of Section 15 and the existing county road. The division lines are at the positions approved by Mr. Campbell.
