

SPRINGER, PROFESSIONAL LAND SURVEYOR, REGISTERED IN THE STATE OF OREGON, HEREBY CERTIFY THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS, THE LAND REPRESENTED AS SHOWN ON THIS PARTITION PLAT, SAID PARTITION BEING A PARTITION OF PARCEL 1, LAND PARTITION PLAT NO. 2005—28, SITUATED IN THE NE1/4 SECTION 1, T.14S., R.31E., W.M., GRANT COUNTY, OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

PARCEL 1 OF LAND PARTITION PLAT NO. 2005-28, ON FILE AND OF RECORD IN THE OFFICE OF THE COUNTY CLERK OF GRANT COUNTY OREGON.

I DO HEREBY DESIGNATE THE 5/8" IRON ON THE NORTH BOUNDARY OF PARCEL 1 AS THE INITIAL POINT OF THIS LAND PARTITION. SAID IRON PIN BEING 1401.63 FEET SOUTH AND 1010.26 FEET EAST OF THE N1/4 CORNER OF SAID SECTION 1, AS SHOWN HEREON.

THIS PARTITION CONTAINS 15.58 ACRES, MORE OR LESS.

- 3. PRIVATE EASEMENT, INCLUDING THE TERMS AND PROVISION THEREOF, AS CREATED ON RECORD LAND PARTITION PLAT NO. 2005–28, ON FILE AND OF RECORD IN THE OFFICE OF THE GRANT COUNTY CLERK. 30 FEET IN WIDTH, AS SHOWN HEREON.
- 4. EASEMENTS, RIGHTS OF WAY AND RESERVATIONS AS THE SAME MAY EXIST OR APPEAR OF RECORD.
