NARRATIVE

This partition was performed at the request of Roy Peterson. The purpose of this partition was to divide the property described in Grant County Deed Instrument No.'s 961477 and 961479 into two parcels.

A search was made of the available records pertaining to this partition and a Public Records report was done by Land Title Co. of Grant County, Inc. The report states that title is vested in Gustav E. Peterson and Ruth L. Peterson. Ruth L. Peterson is deceased.

An unrecorded deed from Gustav E. Peterson, trustee of the Gustav E. Peterson Family Trust, dated July 24, 1996 and trustee of the Ruth L. Peterson Family Trust, dated July 24, 1996, to Roy Richard Peterson, dated October 3, 2012, identified the boundaries of Parcel 2 and an easement for an existing water line to serve Parcel 2. As a result of the unrecorded deed Roy Peterson may have an interest in the property and therefore he has signed this plat. I located the water line as shown on this partition plat. This survey was performed using static GPS receivers and Electronic Total Station. The bearings are based on a GPS observation at the SW corner of Section 2, T8S, R27E, W.M.

A judgment and decree in Grant County Circuit Court Case No. 97—07181CV, dated October 22, 2012, awarded a strip of land in the NW1/4SE1/4 and in the NE1/4SE1/4 of Section 11 and in the NW1/4SW1/4 of Section 12, T8S, R27E, W.M. to the Peterson's trust. A subsequent deed from the Peterson's trust recorded in Instrument No. 20122247, dated October 22, 2012, conveyed the same strip of land to Darryl and Rose Howe.
