


NARRATIVE

This partition survey was performed at the request of the City of Seneca, to partition a portion of the tract of land as described in Deed Book 132, Page 811 of the Grant County Deed Records.

The exterior boundary of this partition, as described in the Surveyor's Certificate, is located based on record surveys, recovered record monuments and deed instruments as shown herein.

The north line of Fourth Street is located based on record survey monuments as shown, and is extended to intersect a line that is parallel to and 120 feet west of the west line of Barnes Avenue, said point being N00°19'24"E, 1320.22 (record N00°22'E, 1320.00) from the SW corner of the Seneca Plat. This locates the West line of the Seneca Plat, which controls a portion of the exterior for this partition.

The deed records for Deed Book 108, Page 847, The United States of America to the City of Seneca, did not have an Exhibit A property boundary description attached. The deed states the parcel of real property is approximately 5.51 acres. The boundary of that tract, as shown herein, is based on the current tax map and the Tax Lot Index Card from the Grant County Tax Assessor. When the area of this tract is calculated, including the alley, Fourth Street and Lots 6, 7 and 8 from the Seneca Plat, the acreage is 5.51 acres.

The City of Seneca replaced it's water transmission mains in 2005. That replacement of the water mains effectively abandoned the old water mains, whose easements were granted in Deed Book 109, Page 5 of the Grant County Deed Records. Refer to the "City of Seneca, Water System Improvement Project As Constructed Drawings" on file at the City of Seneca, which is tied by survey to the SW corner of Section 35.

Parcel 2 and Parcel 3 are placed at the direction of the City of Seneca, with Parcel being the remainder of the tract as described in the Surveyor's Certificate.

The Special Flood Hazard Area, Zone A, located in the Southeast corner of Parcel 1 and crossing over a portion of Parcel 3 is plotted based on an overlay of the Flood Insurance Rate Map, Community Panel Number 410081 0001 B, published by the Federal Emergency Management Agency (FEMA), dated September 24, 1984. It should be noted that the remainder of the City of Seneca is designated as Zone C, areas of minimal flooding, on that map. No flood determination has been made along the Silvies River outside of the City Limits as shown on the said FEMA map.

Know all men by these present that the City of Seneca, a municipal corporation and a political subdivision of the State of Oregon, has caused the lands as described in the "Surveyor's Certificate" to be surveyed and partitioned as shown herein in accordance with O.R.S.
