NARRATIVE

This survey was performed at the request of Kimberly Wirth. The purpose of this survey was to partition the property described in Instrument No. 20062024, deeds of Grant County, into two parcels.

A search was made of the available records pertaining to this survey and for the existing monuments from Grant County Survey No. 824. I accepted the found pins at the SE and SW corners of Block 4 of Allen's Addition to the Town of Long Creek. I found a pin at the NW corner of Block 4 disturbed by the building of a fence which I did not accept. The NE block corner is missing. I re—set these block corners at the record bearing and distance from the found monuments at the SE and SW block corners.
