
LAND PARTITION PLAT NO. 2014-01

A PARTITION OF PARCEL 3 OF LAND PARTITION NO. 2012-10 SITUATED IN GOVERNMENT LOTS 1 AND 2 AND IN THE SE1/4 SECTION 2, T.14S., R.31E., W.M., GRANT COUNTY, OREGON SURVEY COMPLETED FEBRUARY 22, 2014



THIS PARTITION WAS PERFORMED AT THE REQUEST OF CHARLIE STINNETT, WITH THE PURPOSE OF DIVIDING

A SEARCH WAS MADE OF THE AVAILABLE RECORDS. FIELD MEASUREMENTS WERE MADE TO LOCATE EXISTING MONUMENTS FROM RECORD SURVEY NO.'S 232, 259, 286, 1469, 1619 AND 1638, AND LAND PARTITION PLAT NO.'S 98-42, 99-13, 2002-02 AND 2012-10 AND THE PLAT OF LITTLE CANYON HEIGHTS ADDITION.

THE SOUTHERLY BOUNDARY OF THIS PARTITION FOLLOWS THE CENTERLINE OF THE OLD IZEE - CANYON CITY COUNTY ROAD, WHICH WAS VACATED ON SEPTEMBER 24, 1970 BY ORDER OF THE GRANT COUNTY COURT IN BOOK M, PAGE 588 OF THE COMMISSIONER'S JOURNALS. PORTIONS OF THE CENTERLINE WERE SURVEYED IN THE 1970'S AS SHOWN ON MAP OF SURVEY NO.'S 232, 259 AND 558. ALSO, I FOUND IN OUR PRIVATE COMPANY FILES THAT A PORTION OF THE CENTERLINE WAS SURVEYED BY DUANE GRIFFITH, PLS, IN 1971. ALTHOUGH NO MONUMENTS WERE SET AND NO SURVEY WAS RECORDED, GRIFFITH'S SURVEY WAS THE BASIS FOR THE LEGAL DESCRIPTION OF LAND CONVEYED BY ADAM SPROUFFSKE TO ROBERT SKINNER IN 1971 RECORDED IN DEED BOOK 106 PAGE 60. THE NORTHEAST CORNER OF SKINNER TRACT WAS LATER MONUMENTED AS SHOWN ON THE PLAT OF LITTLE CANYON HEIGHTS ADDITION.

I UTILIZED THE FOUND MONUMENTATION FROM SURVEY NO.'S 232, 259 AND 558 AND RECORD BEARINGS AND DISTANCES TO DETERMINE SEVERAL OF THE ANGLE POINTS ALONG THE LINE. FROM THE FOUND MONUMENT FROM LITTLE CANYON HEIGHTS ADDITION AT THE NORTHEAST CORNER OF THE SKINNER TRACT, I HELD DEED RECORD DISTANCES AND ROTATED DEED RECORD BEARINGS 00'00'23" COUNTERCLOCKWISE TO ESTABLISH THE NORTH LINE OF THE SKINNER TRACT. REMAINING PORTIONS OF THE CENTERLINE WERE LOCATED BASED ON PHYSICAL EVIDENCE OF THE OLD ROAD PRISM.



- DRILLED INTO BEDROCK AND SET A 5/8"X6" IRON PIN WITH ATTACHED YELLOW PLASTIC CAP MARKED BENCHMARK SURVEYING
- SET 5/8"X30" IRON PIN WITH ATTACHED YELLOW PLASTIC CAP MARKÉD BENCHMARK SURVEYING
