NARRATIVE

This survey was performed at the request of Darren Pettyjohn. The purpose of this survey was to re-plat a portion Parcel 1 of Grant County Land Partition No. 2018-02 and Parcel 2 and Parcel 3 of Grant County Land Partition No. 2007-27 which are recorded in the office of the Grant County Clerk. Mr. Allen's deed is recorded in Instrument No. 202936. Mr. Pettyjohn's deeds are recorded in Instrument No. 20080544, 20200251 and 20200609.

I accepted the monuments shown as found. Several monuments were missing, which I re—set from the found record monuments as shown. Parcels 2 and 3 of Partition No. 2007—27 and the portion of Parcel 1 of Partition No. 2018—02 between them have been consolidated into one parcel. A new access and utility easement recorded in Instrument No. 20200608 has been prepared to provide an easement for the existing parcels and for future parcels, in the same location as the previously platted partitions.

This survey was conducted using RTK GPS receivers.
